

List of Documents Required for NEET qualified candidates and seeking admission under KEA /NRI (includes Overseas Citizens of India (OCI) and Persons of India Origin)/ Management quota. (The candidate has to bring their original documents for admission in MBBS course (along with 2 SETS ATTESTED PHOTOCOPIES of certificates to be submitted along with the application for admission)

1. Application form for admission to MBBS Course in the prescribed format
2. NEET admit card / Hall ticket
3. NEET Score card / NEET Rank card
4. KEA online application form
5. KEA Verification slip
6. KEA seat allotment letter
7. Fee paid receipt at KEA
8. 10 No's of duly signed Cheque leafs
9. 10th Standard marks card for the proof of date of birth

11. Study certificate from 1st to 12th issued by the Institution
12. Conduct & Character certificate on the School / College letter head. No other certificate in lieu of this will be accepted
13. Income ; Category ; caste (for SC; ST and OBC students)
14. Transfer certificate from the College last studied
15. Migration certificate (other than Karnataka P U Board Student)
16. Eligibility certificate (other than Karnataka P U Board Student)
17. Domicile Certificate
18. AADHAR card of the Candidate and Parents
19. Copy of the PAN card of the parent
20. Medical fitness Certificate with blood group from a MCI Registered medical practitioner
21. **RECENT** Passport size photographs: 8 numbers; recent and identical, with names written in capital letters with year on the back
22. **Two (02) sets of self attested photocopies** of all the above documents by the student / parent as applicable
23. Stamp paper (E-Stamp paper) 8 numbers of the value of Rs.100/- purchased in the name of the student & parent and KANACHUR INSTITUTE OF MEDICAL SCIENCES, MANGALURU
24. **IRREVOCABLE BANK GUARANTEE FROM ANY OF THE NATIONALISED BANK** IN THE PRESCRIBED FORMAT to be submitted at the time of admission.

Joint Notarized affidavits to be executed on Rs. 100/- E- STAMP PAPER, by both the parent/ guardian and the student and submitted at the time of joining:

1. KIMS Institution rules & regulations undertaking
2. KIMS hostel rules & regulations undertaking, for students seeking hostel accommodation
3. Antiragging bond both by the student and the parents, by all the students (Copy of the same should be submitted to the Hostel Warden)
4. Course discontinuation bond (all the students)
5. Fee Payment bond (for Govt. Quota SC & ST candidates)
6. Anti Alcohol / Anti Drug Abuse Policy bond both by the student and the parents, by all the students

In addition to the above, the NRI application should have to submit the following additional documents:

1. Sponsor's resident certificate issued by the Embassy of the country complying the Income Tax Rules
2. Sponsor's passport / VISA / Residents VISA
3. Citizenship of the Candidate, if holding OCI/ PIO
4. Income Tax documents required as per the Income Tax Act 1961 of the sponsorer
5. Degrees/Certificates of the candidates must have been recognized and approved by the Association of Indian Universities (AIU) if the qualifying examination is other than 10+2 of India.
